### Improvements and New Features

- SPDR-PR and SPDR-HA co-existence
- DocAve System Recovery can backup and support an installation by DB2 and SQL Server Database
- Option to delete all related backup data associated with a backup job via the Job Monitor
- Insertion of the DocAve logs into Microsoft Operations Manager (MOM)
- Now if a full backup fails, the related and associated incremental will execute and be treated as a full backup
- Log Manager – Log Data Download, allows the user to collect logs from the Agent Hosts, Media Servers, and Web Servers by selecting a single button within the GUI

### Bug Fixes

- **Doc 310**  
JDBC exception when connecting to MS SQL with logins that have German as the default language
- **Doc 413**  
SPDR HA Mirroring, in relation to the server name, is now case-insensitive
- **Doc 446**  
The version of a file can't be restored when the size of the file is bigger than 5mb
- **Doc 449**  
DB restore failed because the DB server has an alias name

## **Resolved and Included Customer Issues**

### **Backup and Restore**

- **#168: DocAve Item Level – Issue ID Inconsistency**  
Description:  
If the Issue ID is not consistent, the Issue Number will show as the ID Number rather than the Real Item Number.
  
- **#200: DocAve Item Level – Breadcrumbs Break (Out-of-Place Restore)**  
Description:  
Customer tried to use Item Level Backup and Restore to promote a Sub-site to a Top-level site, the result is that the bread crumb trail breaks.
  
- **#205: DocAve Item Level – Excel Document (Out-of-Place Restore)**  
Description:  
User ran an Out-of-Place Restore for an excel document. Restore completed with errors.
  
- **# 251: DocAve Item Level – “List Does Not Exist” (Out-of-Place Restore)**  
Description:  
Customer is doing an Out-of-Place Restore into 2007 and is getting an error when trying to access the restored site via the browser. When trying to open up the default.aspx on the restored site, customer gets "List does not exist".

### **Migrator**

- **#150: DocAve Backup Migrator – Site Groups and Group Owner**  
Description:  
When the Backup Migrator migrates the site groups from SP 2003 to MOSS 2007, the group owner is set to the "System Account".
  
- **#223: DocAve Backup Migrator – List w/ Custom Columns**  
Description:  
A customer is having an issue with migrating over a list with custom columns.
  
- **# 248: DocAve Backup Migrator – Different Domains**  
Description:  
A customer wants to migrate data from SP2003 to SP2007 within different domains. So the user will convert from DomainA\user1 to DomainB\user1.

### **SPDR**

- **#219: DocAve SPDR PR – Alias Name Configuration**  
Description:  
A customer has an issue with SPDR PR when attempting a configuration with an alias name and with a SQL cluster.
